 - Expense Documentation:

Receipts and documentation for the following expenses can significantly impact your personal tax return. Be sure to bring relevant records for review during our meeting:

Employment Expenses:

- Receipts for work-related expenses such as home office expenses, supplies, and tools.
- Travel expenses related to employment.
- Uniform and special clothing expenses.

Medical Expenses:

- Receipts for eligible medical expenses, including prescription drugs, dental services, and medical devices.
- Health insurance premiums not covered by your employer.

Charitable Donations:

Receipts for charitable contributions made during the tax year.

Education Expenses:

Receipts for eligible education expenses, including tuition fees and textbooks.

Homeownership Expenses:

- Property tax statements.
- Mortgage interest statements.

Childcare Expenses:

• Receipts for childcare expenses, including the provider's name and SIN.

RRSP Contributions:

- Records of any additional RRSP contributions made during the tax year.
 - Tax Credits and Deductions:

Any additional documentation supporting tax credits or deductions you may be eligible for.

Remember, thorough documentation of your expenses is essential to maximize your eligible deductions and credits.
